A regular meeting of the Houston City Council was held at 6:00 p.m., Tuesday, October 28, 2025, Mayor John Whitmire presiding with Council Members Amy Peck, Tarsha Jackson, Abbie Kamin, Carolyn Evans-Shabazz, Fred Flickinger, Mary Nan Huffman, Mario Castillo, Joaquin Martinez, Edward Pollard, Martha Castex-Tatum, Julian Ramirez, Twila Carter and Letitia Plummer; Randy Zamora, First Assistant City Attorney, and Marta Crinejo, Agenda Director, present.
