Council Chamber, City Hall, Wednesday, November 12, 2025

A consolidated meeting of the Houston City Council was held at 9:00 a.m., Wednesday, November 12, 2025 with Mayor John Whitmire presiding with Council Members Amy Peck, Tarsha Jackson, Abbie Kamin, Fred Flickinger, Tiffany D. Thomas, Mary Nan Huffman, Mario Castillo, Joaquin Martinez, Martha Castex-Tatum, Julian Ramirez, Willie Davis, Twila Carter and Sallie Alcorn; Arturo Michel, City Attorney, and Marta Crinejo, Agenda Director, present. Council Members Carolyn Evans-Shabazz and Edward Pollard absent due to being ill. Council Member Letitia Plummer absent on personal business.

At 9:08 a.m., Mayor John Whitmire called the meeting to order and led the Invocation on behalf of Council Member Pollard after which he led the Pledge of Allegiance.

#### **MAYOR'S REPORT**

Mayor Whitmire briefly spoke on the alarming rhetoric concerning the collaboration between HPD and ICE. There is no collaboration. HPD strictly follows state and local laws. He wants those who are alarming the community with the false rhetoric and clickbait to stop politicizing a very emotional issue. He asked Douglas Griffith, President of the Houston Police Officers Union, to speak about HPD policies and the collaboration with the different law enforcement entities. He reiterated that HPD only works with other entities when it's necessary (i.e.: warrants from another county, state or federal law enforcement groups).
