- 2. Service(s) performed must match the trade(s) business provides.
- 3. Customer Reference letters must include the service(s) your business performed.

### Category (1)

51% owned and controlled by low-income person(s) provide the following:

□ Completed Section 3 Worker(s) Application

### Category (2)

75% of business labor hours are performed by low-income persons provide the following:

- ☐ List of all Current Full-Time Employees
- Labor Hours Report
- □ List of Eligible Employees with completed Section 3 Worker Applications and required supporting documents

### Category (3)

51% owned and controlled by current public housing residents or residents who currently live in Section 8 assisted housing provide the following:

- Lease Agreement
- Public Housing Voucher or Award Letter





# SECTION 3 BUSINESS CONCERNS FAQ'S



Section 3 is a provision of the Housing and Urban Development (HUD) Act of 1968 which ensures that employment and other economic opportunities generated by certain HUD financial assistance, shall, to the greatest extent feasible, be directed to low and very low-income persons.

The City of Houston Housing and Community Development Department is committed to promoting employment, contracting, and training opportunities to low and very-low income individuals and to business concerns who employ such individuals.

#### WHAT IS A SECTION 3 BUSINESS CONCERN?

A Section 3 Business Concern is a business that provides evidence to qualify under one of the following HUD Regulations categories:

- 1. 51% owned and controlled by low-income person(s); or
- 2. 75% of business labor hours are performed by low-income persons; or
- **3.** 51% owned and controlled by current public housing residents or residents who currently live in Section 8 assisted housing

## WHICH CITY OF HOUSTON HOUSING AND COMMUNITY DEVELOPMENT DEPARTMENT CONTRACTS ARE SUBJECT TO SECTION 3 REQUIREMENTS?

All contracts and subcontracts related to housing rehabilitation, housing construction and other public construction (infrastructure, public facilities, park improvements etc.) valued at or above \$100,000.00 require Section 3 compliance.

### WHAT ARE THE FEDERAL REQUIREMENTS FOR BUSINESSES AWARDED A SECTION 3 COVERED CONTRACT?

- 1. 10% of the construction budget must be directed to Section 3 Business Concerns; and
- **2.** 3% of the non-construction budget must be directed to Section 3 Business Concerns

## WHAT ARE THE SECTION 3 WORKER AND SECTION 3 TARGETED WORKER REPORTING GOAL REQUIREMENTS?

- **1.** Section 3 Workers 25% or more of the total project labor hours must be performed by Section 3 Workers.
- **2.** Targeted Section 3 Workers 5% of the 25% project labor hours must be performed by Targeted Section 3 Workers.
