### **Summary:**

ORDINANCE authorizing and approving a form of agreement for legal services supporting activities undertaken by the Housing and Community Development Department to be executed by the City of Houston, Texas, and each of the following law firms: **BAKER DONELSON**; **BALLARD SPAHR LLP**; **BARRY BARNES & ASSOCIATES**, **PLLC**; and **BEST BEST & KRIEGER**; authorizing the Mayor to execute an agreement for legal services with each firm; authorizing the Mayor to add additional firms who meet the City's specified criteria as set forth in this ordinance; providing a maximum contract amount

## Background:

Request for Proposal received on February 24, 2020, for S83-T29797 - Approve an Ordinance authorizing a form of legal services agreement to support activities undertaken by the Housing and Community Development Department ("HCDD") to be executed by the City Of Houston, Texas ("City"), and each of the following law firms (each a "Firm"): Baker Donalson; Baker Wotring LLP; Ballard Spahr; Barry Barnes & Associates, PLLC; Best Best & Krieger LLP; Beveridge & Diamond, PC; Greenberg Traurig; Hardwick Law Firm LLC; Hawkins Delafield & Wood LLP; Hunton Andrews Kurth LLP; Law Offices of Jennine Hovell-Cox; MarJuana Bush Williams, PLLC; Olson & Olson, LLP; Shannon, Martin, Finkelstein, Alvarado & Dunne, P.C.; The Pierre Law Firm, LLC; and Trest Law; and authorizing the Mayor to execute a legal services agreement with each Firm as needed.

The City Attorney and the Chief Procurement Officer recommend the City Council approve an ordinance awarding a three-year contract with two (2) one year options, with Barry Barnes & Associates, Baker Donelson, Ballard Spahr and Best Best Krieger for housing work to the Legal Department's provision of assistance to the Housing and Community Development Department pertaining to various housing related matters and transactions. The City Attorney may terminate these contracts at any time upon ten (10) days by written notice to the Firm(s) with a copy to the Chief Procurement Officer.

The Request for Proposals (RFP) was advertised in accordance with the requirements of federal and State of Texas procurement laws and regulations. The RFP was advertised in the Houston Business Journal and posted on the Strategic Procurement Division's ebidding website and, as a result, proposals were received from: Ashizawa LLC; Baker Donelson; Baker Wotring LLP; Ballard Spahr LLP; Barry Barnes & Associates, PLLC; Best & Krieger LLP; Beveridge & Diamond, PC; Bradley Law Firm; Greenberg Traurig, Hardwick Law Firm LLC; Hawkins Delafield & Wood LLP; Hunton Andrews Kurth LLP; Law Offices of Jennine Hovell-Cox; MarJuana Bush Williams, PLLC; Michael J. Bostic; Olson & Olson, LLP; Shannon, Martin, Finkelstein, Alvarado & Dunne, P.C.; The Pierre Law Firm, LLC; Trest Law and Walter Law Firm. The proposals were evaluated based on the following criteria:

- 1. Responsiveness of Proposal
- 2. Technical Competence
- 3. Price Proposal

The following firms were recommended and were deemed to be the best qualified law firms to perform the requirements as outlined in the RFP. Each of the following firms were selected for placement on the practice area panel listed below to provide services upon the City's request as the need arises.

As the firms will be engaged on an as-needed basis, it may be necessary to increase, decrease, or transfer allocated funds from one law firm's legal services agreement to another firm's agreement. Accordingly, the Director of HCDD or his designee, from time to time, may increase or decrease the amounts allocated to each Agreement or transfer amounts between each Agreement subject to the availability of funds. Present and out year task orders are expected to be funded, in whole or in part, by grant funds or TIRZ dollars from grants or TIRZ appropriations City Council has already approved or that will be brought forward to City Council pursuant to City policy. The City Attorney may terminate this contract at any time upon ten (10) days written notice to the Firm.

# **MWBE Subcontracting**

The RFP solicitation was advertised with a 24% goal for MWSBE Participation. Each vendor will make good faith efforts to comply with the 24% MWSBE goal as required per the solicitation. The Office of Business Opportunity (OBO) will monitor this award.
