

Public Notice

On Saturday, March 15, 2025, the City of Houston (City) through its Housing and Community Development Department (HCDD) issued a public notice announcing the Spring 2025 Community Meeting and draft 2025-2029 Consolidated Plan (Con Plan), which includes the 2025 Annual Action Plan and Program Year (PY) 2025 proposed budget.

The City is issuing a correction that revises the PY 2025 proposed budget total federal funds from \$49,840,591.00 to \$51,547,917.98. The program income of \$185,646.08 will remain the same.
