**Chair's Report**, David Bucek, Chair, announced speaker rules and meeting procedures.

**Director's Report**, Robert Williamson, Secretary and Deputy Director for the Planning and Development Department, provided updates on three items: City Council public hearing on landmark designations and historic district reclassifications has been rescheduled to 7 January 2026, with public notice forthcoming and Council action to follow at a subsequent meeting; the Norhill Historic District Design Guidelines public hearing was held 12 November and staff is reviewing comments and preparing final revisions for Commission consideration in January; and lastly a new internal window replacement policy has been finalized, clarifying that vinyl windows are not permitted in historic districts to preserve historic character, with the policy now posted on the department's website.




## D. HISTORIC PRESERVATIONS OFFICER'S REPORT –
